TEO's FIF Classification List available in easy-to-search PDF format



If you deal with Foreign Investment Funds (FIFs), then you need a FIF Classification list.

This list classifies all the equities on the ASX & NZX for the purposes of the FIF regime as at 31 March. In addition, it identifies stocks that may be on an approved index, but are stapled or resident in a country other than Australia. Plus this list highlights the additions and removals from the ASX during the income year. The deluxe list (when applicable) also includes share values at the start and end of the year.

LIST TYPES:

Basic FIF Classification List \$287.50 (\$250 ex GST)

This list classifies all equities on the ASX and NZX for the purposes of the FIF regime as at 31 March.

Deluxe FIF Classification List \$575.00 (\$500 ex GST)

This list classifies all equities on the ASX and NZX for the purposes of the FIF regime and includes opening and closing share value for the year ending 31 March.
